

May 10, 1950 - At its annual meeting held last Tuesday evening, the Bradley School District voted 15 to 5 in favor of transporting their students to the Tri Valley School beginning next year. The twenty-odd students affected by this decision are not non-resident students at Liberty Public School.

Mr. and Mrs. David Levitz of Beaver Dam Road are the parents of a son, born at Veterans' Memorial Hospital in Ellenville last Tuesday.

The work on the Lows Corners Tunnel is going forth at record speed. Last week they dug in over 350 feet, which exceeds anything they have ever done before. The tunnel is now in over a mile.

Floyd VanAken has been working on the foundation for a 45 foot tower on Moon Hill about 300 feet from the Red Hill Fire Tower where William Holstington of Rye, N.Y. plans to conduct radar, radio and television experiments. Arrangements are now being made to bring in electric power from Central Hudson lines over Red Hill.

Damage from the severe electrical storm which occurred late Thursday and early Friday, centered in the Red Hill-Claryville area, causing widespread interference with telephone and electric service and killing a cow and calf in the stable of Floyd VanAken.

COUNTY NURSING HOME CRISIS GROWS AS NEW YORKERS GROW OLDER

As New York State struggles to pass a budget, counties throughout the state are feeling the impact. As a result, many counties are being forced to make difficult decisions, not the least of which is how to continue to operate county-run nursing homes in spite of decreasing state commitment.

The fiscal plight of the county nursing homes is a policy issue that has been exacerbated by the increasing population of New Yorkers over 65 years of age, the unsustainable growth of the State's Medicaid program, the unceasing growth of property taxes to pay for public programs, the annual State Budget battles in Albany, and county budget deficits brought on by the recession

"Counties across the state are grappling with how to operate their nursing homes," said Stephen J. Acquario, executive director of the New York State Association of Counties (NYSAC). (Contd. Pg. 4)

A YELLOW PERCH FISH FRY

By Peggy DeWire

Wham! Bam! Somebody pounded on my back door and I recognized the voice of my neighbor's son Fred shouting "Come quick and see what I've got."

I joined him on the porch as he proudly held up a string of yellow perch and we exchanged high fives.

"I just caught them in the brook behind our house." Then I took a picture of the jubilant fisherman.

Yellow perch are the ideal for anglers to start with because they travel in schools and bite on whatever bait is offered, even during the brightest part of the day.

They're abundant predators in ponds, streams and lakes across the east and mid-west and have been introduced in the west. They swim in groups feeding on minnows, crayfish and insects. Perch will even rise to an artificial dry fly during insect

This is an easily recognized pretty fish with an olive green back shading to brilliant yellow sides and belly. Dark stripes are along the sides. It has two dorsal fins, a spiny one followed by a soft-rayed one. Its lower fins are bright orange, especially during breeding season in spring. Yellow perch (Perca flavescens) spawn in roving schools during March - April, the fishes shoaling according to size.

They don't make nests but lay eggs in long jelly-ropes twined around water weeds in the shallows. In depositing them the female glides over the weeds shedding eggs which are then fertilized by one or more attendant

males.

Each egg in its jelly capsule is 1/8" across and there are thousands stuck together in ropes looped around water plants like garlands on a Christmas tree. One large female can lay 100,000 eggs which hatch 8-18 days later, depending on warm weather conditions.

The transparent baby perch _"long, immediately spi-

rals to the surface to fill its air bladder. After this it hangs hidden among water plants. For a month the fry feed on small plankton, graduating to mayfly and mos-

quito larvae and an occasional leech.

In July at two months old. There's a tendency toward cannibalism in schools of tiny yellow perch. Percy mature at three years to a foot long and weigh 1 pound. The oldest recorded was ten years and the biggest was 3 lbs. 8 oz., caught in 1982 in Lake Erie, a record still

These small camouflaged predators hide among stems of water weeds waiting to dart out suddenly and grab prey. Their mouth is small but opens to a surprisingly

wide gape.

A perch's main sense is sight but it can hear and smell too. Nostrils on each side of its head let water flow in and out of a special nasal pouch lined with very sensitive tissue that keeps the fish in touch with its environment.

In winter perch move to deeper water in ponds and lakes, staying quiet to conserve air. Scientists believe that perch may draw oxygen from the air bladder for minimal breathing.

While not considered a prime sport fish, yellow perch are fun to catch and are good eating. A licensed fisherman in New York can catch any number and any size all

vear long. For tasty fried perch, put an equal amount of commeal

and flour in a zippered bag and shake well. Dust perch in this and season to taste then fry in a medium hot skillet until brown, about five minutes on each side. Fish is done when it flakes easily with a fork.

Fred must have read my mind because he lifted the string of fish saying, "Come over for dinner tonight, we're having a perch fry.





"We have 38 county nursing homes in 36 counties outside of New York City."

Counties are in a crisis and are confronted with unique challenges with the health and fiscal stability of public nursing homes.

Those challenges include complying with the unfunded mandates such as Wicks Law and contributing to growing public employee pension rates and health care costs.

"We need to address following questions. Should counties be in the long-term care business? If the answer to that question is yes, then we need to develop funding formulas or financing mechanisms that do not require annual property tax increases to keep them open," said NYSAC President Tom Santulli.

To address these questions, county leaders from across the state are convening a Nursing Home Summit in Ulster County on May 25, 2010. The issues that will be addressed include:

Long term care reimbursement and the NYS budget crisis.





All deploying members were medically screened according to CDC guidelines and prepared for the environment with essential gear and supplies donated by Gander Mountain, Wal Mart, and others. They arrived in Port Au Prince on January 21, 2010 at 11:20 a.m. and were immediately tasked food distribution efforts and incident command attracture assistance. incident command structure assistance.

Transportation was provided via a private aircraft flight that Save the Children had arranged with its donors to deliver critical medical supplies. The Sheriff accompanied the volunteers to Port Au Prince to assess the mission objectives and meet with Save the Children managerial personnel. He was back in New York at 7:00 p.m. on the same day.

This deployment is initially expected to last twenty one days. The members have been granted leave by the Sheriff and avenues are being pursued for reimburse-ment for Ulster County. All three members personally volunteered and offered the usage of their earned vacation time to assist in this relief effort. "They are trained to help people. For them, it's a once in a lifetime oppor-tunity to respond quickly and make an impact saving lives," Van Blarcum said. "Knowing that their absence would not disrupt the function of our Office and having confirmed the integrity of the mission I am proud to support their efforts.

The Sheriff's Office has had over thirty members volunteer to go to Haiti to assist in this effort with many

others offering financial assistance.





residents cannot wait to leave the house and spend time outdoors. Many tourists also travel to Ulster County to enjoy the area's natural beauty. However, because of the risk of tick-borne illnesses - including Lyme Disease - it is crucial that everyone learn not apply to the hands of small children. "A little bit of prevention can help residents and visitors safely enjoy all of the magnificent parks, trails, wilderness areas and outdoor activities in Ulster County," said County Executive Mike Hein. "I encourage everyone to take note of, and practice the guidelines outlined by our Health Department."

In addition to Lyme disease, infected ticks can trans-mit diseases including Rocky Mountain spotted fever, babesiosis and ehrlichiosis. The effects of these diseases can be severe. Generally, if you remove an attached deer tick within 36 hours, the risk of Lyme Disease infection is greatly reduced.

Tick Prevention and Removal Guidelines:

-In wooded and grassy areas, wear light-colored clothing (to spot ticks better) and tuck pants into socks and shirt

-Every two to three hours outdoors' check for ticks on clothing or skin. Brush off any ticks on clothing before they attach to your skin.

-Do a thorough tick check of your entire body at the end of the day. Pay particular attention to the back of the knees, behind the ears, the scalp, the arm pits and your back. Check your kids and pets too.

-To remove a tick: Using tweezers, grasp the tick near the mouthparts, as close to the skin as possible. Pull the tick in a steady, upward motion away from the skin. Don't squeeze, crush or puncture the body of the tick, which may contain infectious fluids.

o After removing the tick, disinfect the bite area with soap, rubbing alcohol or hydrogen peroxide. Wash your hands carefully. Record the date and location of the tick bite. If a rash appears or if you experience flu-like symp-toms over the next 30 days, contact your health care provider immediately.

-Consider using insect repellents to reduce tick bites. Follow label instructions carefully. Use repellents only in small amounts and avoid unnecessary repeat applications. During the warmer months, most Ulster County esidents cannot wait to leave the house and spend me outdoors. Many tourists also travel to Ulster to repellents, in part because their exposure may be greater. Do not apply repellents directly to children. Apply to your own hands and then put it on the child. 



UC EXECUTIVE ANNOUNCES FILING OF ANNUAL FINAN-CIAL REPORT FOR FISCAL YEAR ENDED DECEMBER 31, 2009

Ulster County Executive Michael P. Hein announced that Commissioner of Finance Paul J. Hewitt completed and filed the 2009 Ulster County Annual

Financial Report with the State Comptroller on April 30, 2010.

The 2009 Unreserved/Unappropriated General Fund Balance was \$18.2 million. In 2008, the Unreserved/Unappropriated General Fund Balance was \$23.9 million. It is recommended by the State Comptroller's Office that municipalities maintain an unreserved/unappropriated fund balance of between 5% and 10% of their total general fund budget. The \$18.2 million represents approximately 6.5% of the County's general fund budget.

The Commissioner of Finance reported that, in 2009, the 2009 total general revenues were \$ 258.4 million and the 2009 total expenditures were \$259 million. The 2009 near-breakeven fiscal year had to overcome a \$7.3 million drop in sales tax. This was accomplished through focused cost management and aggressive fiscal oversight.

"Through a combination of cost restraints, increased federal revenues and revenues from prior years my administration was able to compensate for a significant drop in sales tax revenue, said County Executive Hein." "This is consistent with our commitment to protect the taxpayers of Ulster County. While this news is promising, we still need to proceed with my 10 point Taxpayer First Initiative to begin closing the projected budget gap for fiscal year 2011."

County Executive Hein continues to be cautious with these numbers as the

current economic downturn could result in a loss of revenues, specifically in the areas of sales tax and potential impacts from the failure of state officials to pass an on time budget. These unprecedented situations may well lead to downward fund balance pressures throughout 2010.

HINCHEY VOTES YES TO HELP HOME-OWNERS AFFORD ENERGY SAVINGS RENOVATIONS-

With home improvement season swinging into full gear, families may soon have an added incentive to invest in energy saving upgrades, which reduce energy bills and lessen our nation's dependence on oil from hostile nations. Homeowners will receive up to \$1,500 per improvement with a maximum rebate of \$3,000. The Gold Star program rewards homeowners who conduct a comprehensive energy audit and implement measures to reduce energy use. Under this option, consumers will receive \$3,000 for a demonstrated savings of 20 percent, plus an additional \$1,000 for each additional 5 percent energy savings up to \$8,000. Rebates for both programs may not exceed 50 percent of the total project

With high unemployment in the U.S. construction industry, the Home Star bill also provides a needed boost. Economists estimate that the market-based incentives in the program would create 168,000 American jobs in construction, manufacturing and retail industries. More than 90 percent of the materials and products used in eligible measures are made in the U.S. In the long run, it helps rebuild the foundation of our economy by encouraging American innovation and entrepreneurship in the growing clean energy industry.

As a result of the program, over 3 million American families stand to save up to \$500 per year on their energy bills, totaling \$9 billion over the next ten years. The legislation will also help reduce our dependence on oil imported from hostile nations by cutting the equivalent of almost 7 million barrels of heating oil next year.

The bipartisan legislation enjoys broad support from business, labor, environmental and consumer groups including President Obama, the National Association of Manufacturers, U.S. Chamber of Commerce, National Association of Home Builders, Owens Corning, Home Depot, Laborers' International Union of North America, Natural Resources Defense Council, and the Home Star Coalition with over 1000 business and organization members nationwide.

Hinchey also strongly supported and voted for the American Recovery and Reinvestment Act, which made jobcreating investments in a clean energy future and provided tax rebates for energy efficiency improvements. GILLIBRAND, LEADERS CALL FOR SENATE HEARINGS TO INVESTIGATE COMPANIES DOING BUSINESS WITH

IRAN (From Pg. 1)

"Under his leadership, Iran has armed Hezbollah in Lebanon and Hamas in the Gaza Strip. Under his leadership, Iran is developing nuclear weapons, which threaten the stability of the Middle East. Ahmadinejad is coming to a conference that is supposed to recommit nations to the principles of disarmament, nonproliferation and the peaceful use of civil nuclear energy. But there is every indication that Iran is dedicated to the principles of rearming, nuclear proliferation and the aggressive use of nuclear weapons."

"Once again, President Ahmadinejad has come to the United Nations to spout duplicitous and anti-Semitic propaganda before a world stage," said Representative Nadler. "We must join together to continue to denounce his regime's odious policies of illegal nuclear proliferation, hatemongering, and malevolent disregard for the outside world. I have proudly supported the House's efforts to step up sanctions against Iran and I believe we must continue to push the Iranian government to abandon all efforts to develop nuclear weapons. And we must not tolerate

the continued flouting of sanctions by companies engaged in commerce with Iran - there is no excuse for doing business with a tyrannical regime. "In 2007, President Ahmadinejad used his visit to pull offensive PR stunts like attempting to visit the

World Trade Center and spouting off inflammatory remarks and conspiracy theories at Columbia University," said Representative Nita Lowey. "He should use this trip to join the community of nations by answering long-overdue questions about Iran's nuclear program, coming into compliance with the Nuclear Nonproliferation Treaty (NPT), and ceasing

his pursuit of nuclear weapons.

As we have all seen, the President of Iran has used his office not as a vehicle for peace and prosperity but as a way of increasing tensions in a region that is already under far too much pressure," said Council Speaker Christine C. Quinn. "What is even more troubling is that here at home, American businesses continue to invest in a country led by a tyrannical regime. Congress must hold hearings to investigate these com-panies and must pass tougher sanctions. Investment in Iran must not come at the expense of our national security or our core democratic values."

"It has become clear that Iran's nuclear program is a threat to all who embrace freedom and democratic values," said John Ruskay, executive vice president and CEO of UJA-Federation of New York. "President Ahmadinejad has clearly expressed his hopes and aspirations. We stand with all who reject them--for the people of Iran, the entire region, and far beyond. We

must not and will not remain silent."

The New York Times last month uncovered 74 businesses in America and around the world are doing business both with the American government and with Iran's oil and gas sector. America has awarded over \$100 billion in contracts and grants to businesses that invest in Iran's fossil fuel industry, including \$15 billion in companies potentially violating current American sanction laws.

Due to recent public exposure, nearly 20 companies have recently disinvested from Iran, including 15 that stopped selling gasoline to the nation. But for every business that has divested, more than three continue enabling Iran's nuclear ambitions that threaten Israel, America and countries everywhere.

Senator Gillibrand and the New York leaders are calling for Senate hearings to investigate companies reported of doing with business in Iran, and forcing them to cut ties with the hostile nation or lose access to business in America and the rest of the world. The leaders are also calling on Congress to immediately pass a new Iran sanctions law that would allow President Obama to impose tougher sanctions and checks against companies tied to Iran, including blocking federal contracts to violators and imposing a three year ban on government contracts against companies who falsely claim they do not conduct business with Iran.

SC COMMENCES REVIEW OF STRATE-GIC PLAN THAT WILL SET BUDGET AND PROGRAMMATIC PRIORITIES FOR 2011 & 2012

Legislature Chairman Jonathan F. Rouis announced that the County Legislature will commence a review of the County's Strategic Plan, during Legislative Committee meetings on Thursday, May 6, 2010, and Thursday, May 13, 2010. The County's Strategic Plan will set the budget and programmatic priorities for 2011 and 2012.

"The Legislative Committees will receive presentations from the Division Commissioners and Department Heads, during the regularly scheduled May meetings," said Rouis. "This process will begin the opportunity for the Legislature to formulate the foundation upon which the County's budget will be developed," added Rouis.

The County Manager, David P. Fanslau, submitted his recommendations, along with the requests of the Division Commissioners, Elected Officers, and Department Heads to the Clerk of the County Legislature on April 1, 2010. The Sullivan County Charter requires that the County Manager submit recommendations by April 1st, bi-annually. Thereafter, the County Legislature must adopt a two-year strategic plan by June 30, 2010.

The Strategic Plan requirement was added to the County Charter as part of the fiscal improvements recommended by the County Manager in 2007. The Strategic Plan sets the foundation of the County budget process, followed by the six-year Capital Plan as amended, and finalized with the tentative budget for the ensuing fiscal year. The Strategic Plan provides the intent and priorities of the County Legislature to the County Manager, as he develops the tentative budget.

"The prolonged national Great Recession will require that the Strategic Plan incorporates initiatives to avoid costs wherever possible," said Rouis.

There will be a desire to build upon the successful cost avoidance that the County has experienced through the implementation of the Multi-Functional Devices that replaced more than 300 stand alone office machines, and the cost avoidance by transforming the telephone system to a more cost-effec-

tive approach," said Rouis.

"The County Government must continue to review every idea, and develop approaches to reduce the cost of providing the services that the citizenry has come to expect," concluded Rouis.

ASSEMBLYWOMAN AILEEN GUNTHER OBJECTS TO GOVERNOR PATERSON'S PLAN TO CUT BUSINESS TAX CREDITS

Assemblywoman Aileen Gunther (D, C, I -Forestburgh) is adamantly opposed to this plan. This action will hurt the economy, cost jobs, and will be detrimental to so many New Yorkers.

"Governor Paterson needs to wake up," said Gunther." This is no way to close the budget gap. This would be devastating to these already strug-

gling businesses in our region."

This plan takes back commitments the state has made to businesses. Many counted on these incentives and based their investments and decisions on their impending tax credits. The Governor's proposal will delay more than 30 tax credits which include historic preservation benefits, brownfield remediation credits, and Empire Zone benefits.

"These are desperate times," said Gunther. "We need to control costs and balance the budget, but this plan of reneging on commitments is unacceptable."

MILITARY OFFICERS ASSOCIATION OF AMERICA ENDORSES HINCHEY'S CARMELO RODRIGUEZ MILITARY MEDICAL ACCOUNTABILITY ACT BILL WOULD PROVIDE LEGAL RIGHTS TO MEMBERS OF THE MILITARY WHO SUFFER MEDICAL MALPRACTICE IN MILITARY MEDICAL FACILITIES

In response to the Military Officers Association of America's (MOAA) endorsement of the Carmelo Rodriguez Military Medical Accountability Act of 2009 (H.R. 1478), Congressman Maurice Hinchey (D-NY) today released the following statement. Hinchey wrote and introduced the legislation, which the Judiciary Committee passed and now awaits a vote by the full House. A companion bill has also been introduced by Senator Schumer.

'Today, the Military Officers Association of America (MOAA) offered their endorsement for the Carmelo Rodriguez Military Medical Accountability Act, which I authored and introduced last year. I am very pleased to have their support for this essential legislation, which provides legal rights to members of the military who suffer medical malpractice in military medical facilities. With over 370,000 members, MOAA is the largest and most influential association of military officers. Their support provides added momentum to this legislation, which now awaits a vote by the full House after its successful passage by the Judiciary Committee.

"Each year, members of the uniformed services who fall victim to medical malpractice have no opportunity for the same legal recourse granted to all other U.S. citizens, including veterans and even federal prisoners. One such service member was Sergeant Carmelo Rodriguez, of Ellenville, NY, who at the age of 29, died of skin cancer that was repeatedly misdiagnosed and flagrantly mishandled by the military medical establishment. The 7-year old son and family he left behind currently have no legal recourse for this tragic case of malpractice. Those who were at fault have not been held accountable.

"Hundreds of service members are living with wounds inflicted not by an enemy, but instead by a system in which there is no right to choose your own doctor and no right to hold him or her accountable when an unforgivable mistake is made. The need for this legislation could not be more urgent or more clear.

GILLIBRAND PUSHES TSA TO AUTO-MATICALLY CONNECT NO-FLY LISTS WITH FLIGHT MANIFESTS, ALSO WANTS PENALTIES FOR AIRLINES THAT AREN'T CROSSCHECKING NO-FLY LISTS

After Faisal Shahzad made it onto an airplane at John F. Kennedy Airport and nearly left the U.S. after his Times Square bombing attempt, U.S. Senator Kirsten Gillibrand is urging the Transportation Security Administration (TSA) to automatically synchronize federal no-fly lists with flight manifests. On the way to automation, Senator Gillibrand is pushing for fines to penalize airlines that do not check the no-fly list or submit their manifests in a timely manner.

Senator Gillibrand wrote to TSA Acting Administrator Gale D. Rossides urging her to implement the new protections immediately.

"If airlines can automatically coordinate with Travelocity, they should be able to automatically check the TSA's no-fly list," Senator Gillibrand said. "Ten years after 9/11, there is absolutely no reason why we cannot automatically crosscheck flight manifests with the no-fly list. We need streamlined security checks that ensure our airlines and our law enforcement are always a step ahead of terrorists that seek to harm New Yorkers and all Americans.

Senator Gillibrand's plan to implement faster security checks:

 Fines for airlines that do not check the no-fly list or submit their manifests in a timely manner. There is a process for the FAA and TSA to address an airline's non-compliance, but no sanction specifically tied to timely checks of the no-fly list.

 Automated coordination between the no-fly and flight manifests. There is currently no automated, real time verification between the no-fly database

and airline manifests.

· Finalize agreements with foreign airlines. Currently, TSA agents have the right to agents to spot check manifests only of US domestic airlines

Current and forecast weather conditions at six locations are updated daily. There is a photo gallery, and submissions of Catskills photos are welcome. Site visitors may also sign up for a forthcoming electronic newsletter, or send comments to a regional blog.
